We have also jointly commissioned a regional Affirmatively Furthering Fair Housing Market Study that is near completion. We will work together to address the housing shortage identified in this study</p>

The LCHA continues to meet or exceed HUD's goal to ensure that at least 40% of new housing admissions are at or below 30% of County Median Income. All LCHA affordable housing apartments are rented to families at or below 60% of county median income.</p>
